Application Packet for 2021-2022 Local Grant Program, Archdiocese of St. Louis

The Catholic Campaign for Human Development (CCHD) is the domestic anti-poverty program of the U.S. Catholic bishops. The CCHD grant program is made possible by the generous support of Catholics in the United States, especially through an annual parish collection, and is committed to supporting organizations working to break the cycle of poverty and improve local communities.

The CCHD grant program of the Archdiocese of St. Louis may award a maximum of \$10,000 to organizations, both Catholic and non-Catholic, located within the Archdiocese.

The CCHD funds two types of grant projects:

Community development projects nurture solidarity between the poor and non-poor, facilitating the participation of people living in poverty in the institutional decisions that perpetuate poverty in their lives. In these projects, low-income people gain the ability to identify barriers, brainstorm solutions, and create institutional change by taking action to change problematic structures and systems in their communities. These projects should directly benefit a relatively large number of people rather than a few individuals.

Economic development projects significantly include the voice of poor and marginalized people in developing new businesses that create social benefits, offer good jobs, and/or develop assets that will be owned and enjoyed by local communities. Ideally, these CCHD-funded projects will include collaboration with other organizations and will encourage project beneficiaries to work to effect institutional change in additional areas.

Additional criteria include:

A demonstrated practice of subsidiarity: Central to CCHD is the belief that those who are directly affected by unjust systems and structures truly have the best insight into how to change them. The participation of low-income people in the shaping and ongoing direction of a CCHD-funded organization is critically important. Low-income people must have and maintain a strong voice in the organization's leadership, both in its governance structure and its policy decisions. Within a CCHD-funded organization, there must also be evidence of leadership development processes that prepare low-income people to participate in leadership roles, including service on the board of directors.

An affirmed compliance with Catholic moral and social teaching: A CCHD-funded organization must not participate in or promote activities that contradict the moral and social teachings of the Catholic Church including supporting or promoting same-sex marriage, discrimination, capital punishment, abortion, euthanasia, or punitive measures towards immigrants. A nonpartisan perspective when engaging in political activities: CCHD-funded organizations may not participate or intervene in political campaigns on behalf of or in opposition to candidates for public office. Get Out the Vote (GOTV) activities and voter education efforts must be conducted in accordance with IRS rules applicable to section 501(c)(3) organizations.

A clear vision for development of financial capacity: A CCHD-funded organization has a plan for sustainability including, for instance, membership dues, grassroots fundraising, foundation or corporate support, and other strategies for fundraising.

A focus on justice versus charity: While the Catholic Church supports many programs that address charitable needs, CCHD funding focuses on reducing the need for charitable help. CCHD-funded projects focus on creating systemic change as opposed to providing direct services such as food, childcare or counseling services, scholarships, referrals, or recreation services.

Organizations controlled by governmental or educational bodies and individually-owned, for-profit businesses are ineligible for funding. Organizations which have received local CCHD funds for six years are ineligible for the subsequent three years and no single project may be funded for more than three consecutive years. CCHD-funded organizations may not use grant funds for re-granting purposes.
